



## **LIMITED WARRANTY: PROMOTION**

### **LIMITED WARRANTY COVERAGE DETAILS**

1. COVERAGE FOR FAILURES DUE TO DEFECTS IN MATERIALS AND WORKMANSHIP WILL BE DETERMINED BY POLARIS IN ITS SOLE DISCRETION. COVERAGE EXISTS ONLY FOR DEFECTS IN MANUFACTURING WORKMANSHIP OR MATERIAL. ANY NON-FACTORY AUTHORIZED MODIFICATIONS VOID COVERAGE. NORMAL WEAR ITEMS AND CONSUMABLE ITEMS ARE NOT COVERED.
2. A \$50 DEDUCTIBLE WILL APPLY TO EACH REPAIR VISIT AFTER THE STATED STANDARD WARRANTY COVERAGE.
3. SO LONG AS THE RECOMMENDED MAINTENANCE IS COMPLETED AND DOCUMENTED THERE IS NO MILEAGE LIMIT ON THE PROMOTIONAL EXTENDED WARRANTY.
4. PROMOTIONAL EXTENDED WARRANTY IS TRANSFERRABLE; IT IS THE RESPONSIBILITY OF THE NEW OWNER TO ATTAIN ALL NECESSARY RECORDS FOR COVERAGE TO REMAIN VALID.
5. VEHICLES USED FOR RACING OR RENTAL ARE EXCLUDED FROM COVERAGE.
6. NO ADDITIONAL OR SUPPLEMENTARY BENEFITS WILL BE INCLUDED IN COVERAGE UNLESS OUTLINED.

### **LIMITED WARRANTY COVERAGE AND EXCLUSIONS: LIMITATIONS OF LIABILITY**

1. DAMAGE RESULTING FROM ABUSE, NORMAL WEAR, OR LACK OF PROPER MAINTENANCE IS NOT COVERED BY THIS WARRANTY.
2. COVERAGE EXCLUDES THE FOLLOWING: BATTERY, BATTERY CABLES, AIR FILTER, OIL FILTER, COOLANTS, FLUIDS, CAM CHAIN TENSIONER ASSEMBLY, CAM CHAIN TENSIONER SHOE, PRIMARY CHAIN TENSIONER ASSEMBLY, PRIMARY TENSIONER SHOE, SPARK PLUGS, PLUG WIRES, SECONDARY DRIVE CHAIN AND SPROCKETS, PRIMARY OR SECONDARY DRIVE BELTS AND SPROCKETS/PULLEYS, CLUTCH BELTS, RUBBER OR OTHER MATERIAL COMPOSITION HOSES, ANY COMPONENT FOR WHICH ITS ONLY PURPOSE IS FOR ILLUMINATION, LENSES, EXHAUST PIPES, MUFFLERS, RESONATORS, CATALYTIC CONVERTERS OR ANY PART THEREOF, BLUEING, DISCOLORATION, OR RUSTING OF EXHAUST PIPES, EXHAUST GAS OXYGEN SENSORS, EMISSION COMPONENTS, ANTENNAS, SPEAKERS, TIRES, WHEEL BEARINGS, SPOKES, RUBBER MOLDINGS, GLASS, METAL, CHROME PLATING, OR PLASTIC TRIM, LENSES OR UPHOLSTERY; BRAKE PADS, SUSPENSION BUSHINGS.
3. THIS WARRANTY ALSO EXCLUDES FAILURES RESULTING FROM IMPROPER LUBRICATION; IMPROPER ENGINE TIMING; IMPROPER FUEL; SURFACE IMPERFECTIONS CAUSED BY EXTERNAL STRESS, HEAT, COLD OR CONTAMINATION; OPERATOR ERROR OR ABUSE; IMPROPER COMPONENT ALIGNMENT, TENSION, ADJUSTMENT OR ALTITUDE COMPENSATION; FAILURE DUE TO SNOW, WATER, DIRT OR OTHER FOREIGN SUBSTANCE INGESTION/CONTAMINATION; IMPROPER MAINTENANCE; MODIFIED COMPONENTS; USE OF AFTERMARKET COMPONENTS; UNAUTHORIZED REPAIRS; REPAIRS MADE AFTER THE WARRANTY PERIOD EXPIRES OR BY AN UNAUTHORIZED REPAIR CENTER; USE OF THE PRODUCT IN COMPETITION OR FOR COMMERCIAL PURPOSES. WARRANTY WILL NOT APPLY TO ANY PRODUCT WHICH HAS BEEN DAMAGED BY ABUSE, ACCIDENT, FIRE OR ANY OTHER CASUALTY NOT DETERMINED A DEFECT OF MATERIALS OR WORKMANSHIP.

THE EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY SHALL BE, AT POLARIS' OPTION, REPAIR OR REPLACEMENT OF ANY DEFECTIVE MATERIALS, COMPONENTS, OR PRODUCTS. THE REMEDIES SET FORTH IN THIS WARRANTY ARE THE ONLY REMEDIES AVAILABLE TO ANY PERSON FOR BREACH OF THIS WARRANTY. POLARIS SHALL HAVE NO LIABILITY TO ANY PERSON FOR INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES OF ANY DESCRIPTION, WHETHER ARISING OUT OF EXPRESS OR IMPLIED WARRANTY OR ANY OTHER CONTRACT, NEGLIGENCE, OR OTHER TORT OR OTHERWISE. THIS EXCLUSION OF CONSEQUENTIAL, INCIDENTAL, AND SPECIAL DAMAGES IS INDEPENDENT FROM AND SHALL SURVIVE ANY FINDING THAT THE EXCLUSIVE REMEDY FAILED OF ITS ESSENTIAL PURPOSE. THE IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE IS EXCLUDED FROM THIS LIMITED WARRANTY. ALL OTHER IMPLIED WARRANTIES (INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTY OF MERCHANTABILITY) ARE LIMITED IN DURATION TO THE STANDARD WARRANTY PERIOD. POLARIS DISCLAIMS ALL EXPRESS WARRANTIES NOT STATED IN THIS WARRANTY. SOME STATES DO NOT PERMIT THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES OR ALLOW LIMITATIONS ON THE DURATION OF IMPLIED WARRANTIES, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU IF INCONSISTENT WITH CONTROLLING STATE LAW.
